Homeowners Forum: Eileen Parker would like to see minutes put online in a more timely manner. She would also like to have more communications from the board in general.

Approval of November Minutes: Minutes had already been unanimously approved via email.

Miscellaneous – Annual Meeting:

- There was some discussion regarding whether to hold an open air meeting or meet via Zoom. There was general agreement that Zoom was probably the best way to go.
- Will have to figure out how to hold votes and how to handle proxies.

Treasurer's Report: Kendra Conrad reported.

- Kendra quickly went through the end of year financials. Areas in which we were noticeably over or under budge were highlighted. Water is clearly a problem area that will be addressed in next year's budget.
- A number of residents have asked to be able to pay dues electronically. Kendra reported that Vectra Bank would charge the HOA \$35 / month for an ACH account. Issue was tabled for now.

Landscaping and Grounds: Jim Bruzas reported.

• Water of the common areas was over budget. That has always been a problem area in that it is difficult to know what the summer will be like.

- Water bill for IRR F was extremely high, but something hard to control because it is watered from a private home. Jim will check again with the water department to see what having a tap installed would cost.
- Snow removal costs were about \$350 over budget.
- Would like to do some thorough tractor maintenance in the spring and schedule that for every other year
- Trying to get the tree prunings in the various common areas on a rotating basis

Pool: Jason Fish reported.

• Not opening the pool because of Covid 19 put us about \$4500 under budget.

Architectural Committee: Sarah Gabriele reported that there hasn't been much activity.

Tennis Courts: Jason Rogers reported that there are no isues.

Website: Jason Rogers reported that nothing new was happening with the website.
