Reminder: Collection Policy

Please remember that it is important to the operation of our community that dues be paid on time and in full (including any outstanding late fees/fines)! A \$20.00 late fee will be assessed each month the dues are not paid in addition to a 8% per annum on the outstanding balance. If any balance becomes more than 90 days delinquent, the account is turned over to the Association attorney for collection. Homeowners with an overdue balance will not be allowed access to the HOA recreational facilities. Trash collection is every Thursday with exceptions for Holidays and inclement weather. Recycling is every other Thursday.
